1) Subject matter

Mobile phones produced with environmentally friendly materials and processes and with an environmentally friendly in the use and waste phase.

2) Exclusion criteria

Non compliance with environmental and social legislation, which has been the subject of a final judgment or a decision having equivalent effect, may be considered an offence concerning the professional conduct of the economic operator concerned or grave misconduct, permitting to exclude the party concerned from competing for the contract

4) Technical specifications

a) Recycling of the product

- The products are designed that they can be easily dismantled for recycling purposes in order to separate and, if possible, recycle case plastics and accumulators as fractions of materials of other functional units. The products are so designed that dismantling by a specialized firm is supported by an intelligently arranged connection design or can be done by use of common tools.
- Plastic case parts (exceeding 10 grams) are marked according to ISO 11469. Other case materials are named.



b) Material requirements

- Chlorinated or brominated polymers and additions of chlororganic or bromoorganic compounds as flame retardants are not used.
- Lead and cadmium as well as their compounds are not added to the plastics and coatings used.
- The printed circuit board doesn't contain any polybrominated biphenyls (PBB), polybrominated diphenyl ethers (PBDE) or chlorinated paraffins.
- Cadmium, mercury as well as beryllium and their compounds are not used in electronic components.

c) Battery

- Batteries and accumulators don't contain lead, cadmium or mercury.

d) Other

- The supply includes an external earpiece and a speaker (so-called headset). *Evidence:*
